The person referred to as the skipper is the skipper. In the event of his failure or inability, the person designated as co-skipper (see back) takes over the ship's command.

The skipper conducts a safety briefing for all participants, instructs them in the special features of the yacht and documents this in the logbook.

The skipper's seamanship rights and duties shall take precedence, irrespective of these agreements. As a gratuitous courtesy, the skipper takes over exclusively the tasks of the ship's command and the associated seafaring care of the crew.

IV. Basis

1. The undersigned conclude this crew contract for the implementation of the following sailing trip, which serves exclusively as a joint holiday trip – without making a profit.

2. The operation of the trip is carried out on the basis of the charter contract, the content of which is known to the undersigned and the component of this crew contract.

3. Risks and obligations

Participation in this sailing trip and the associated activities is at the own risk of each participant. He hereby declares that he is fully responsible for himself (and those entrusted to him, if any) and that he takes the measures necessary for personal safety. This includes, among other things, putting on life belts, life jackets and other safety devices on the lower and upper decks and in the water. The participants declare that they can swim.

In addition, each participant undertakes to immediately follow the instructions of the skipper necessary for the management of the vessel and to immediately inform the skipper of any event that could endanger the safety of persons, property or vessel.

V. Disclaimer

The participants exclude any liability against the skipper and the other fellow sailors, unless it is intentional or gross negligent and is not covered by skipper's liability insurance from YACHT-POOL.2 This applies to culpably caused personal injury and property damage to the participants.

VI. Withdrawal

Withdrawal or termination of the charter trip of one or more participants does not release them from their obligation to pay.

In the event of withdrawal of one or more crew members, the full portion of the charter price and, if applicable, the airfare is due. It is up to the skipper's decision to accept a substitute member if necessary. It is strongly recommended to take out a YACHT-POOL charter cancellation insurance.

Should individual provisions of this contract be invalid, this shall not affect the validity of the remainder of this contract. In such a case, the parties will endeavour to reach an agreement that comes as close as possible to the purpose of the invalid provision.

Deviations from this contract or changes must be made in writing. YACHT POOL or the Charter Operator who passes on this model contract may, in the event that a legal dispute arises between crew members or crew members and skippers.

VII. Notes

1 In the event that the deposit is insured, only the insurance premium must be paid.

2 Exclusions of liability of third parties are not possible through a crew contract. In this case, third parties are, for example, the wife and children in education of the injured participant. This does not exclude liability for damages caused by gross negligence or intent towards the owner of the chartered yacht. The skipper and crew shall be liable to him outside of this contract.

This sample contract serves as an aid and does not claim to be complete. Despite the fact that careful consideration of legally relevant points, liability for the content cannot be assumed.
